BE IT RESOLVED BY THE QUORUM COURT OF GRANT COUNTY, ARKANSAS, THAT NOTICE BE PUBLISHED; THAT A VACANCY IN OFFICE OF CONSTABLE, SIMPSON TOWNSHIP BE DECLARED; THAT THE GOVERNOR OF THE STATE OF ARKANSAS BE NOTIFIED OF THE VACANCY; AND FURTHER THAT LOUISE LAVELLE BE COMMENDED FOR THE YEARS OF SERVICE TO THE COUNTY AND TO THE CITIZENS OF GRANT COUNTY

WHEREAS, LOUISE LAVELLE, CONSTABLE, PASSED AWAY ON SUNDAY, FEBRUARY, 19 2017;

WHEREAS, THE QUORUM COURT OF GRANT COUNTY, ARKANSAS, WILL CONVENE ON THE 20<sup>TH</sup> DAY OF MARCH AT 7 O'CLOCK PM AT THE GRANT COUNTY COURTHOUSE TO DECLARE A VACANCY IN OFFICE OF CONSTABLE;

WHEREAS, NOTICE OF THE PASSING OF CONSTABLE, SIMPSON TOWNSHIP SHALL BE PUBLISHED IN A NEWSPAPER OF GENERAL CIRCULATION;

WHEREAS, UPON APPROVAL OF THIS RESOLUTION AND DECLARATION OF THE VACANCY IN THE OFFICE OF CONSTABLE, SIMPSON TOWNSHIP AN EXECUTED COPY OF THIS RESOLUTION SHALL BE SENT TO THE GOVERNOR;

WHEREAS, LOUISE LAVELLE SERVED THE CITIZENS OF GRANT COUNTY AS A DUTIFUL CONSTABLE FOR SIX TERMS, FIRST BEING APPOINTED TO FILL THE VACANCY OF HER HUSBAND ON APRIL 19, 2004;

WHEREAS, LOUISE LAVELLE GAVE UNSELFISHLY TO HER COMMUNITY AND HER STATE, SHE SERVED AS CHURCH SECRETARY AT THE CORINTH MISSIONARY BAPTIST CHURCH, AND RETIRED AFTER 43 YEARS AS THE LONGEST SERVING EMPLOYEE AT THE ARKANSAS STATE POLICE;

NOW THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF GRANT COUNTY, ARKANSAS, THAT NOTICE OF THE MEETING TO DECLARE THIS VACANCY HAS BEEN DULY PUBLISHED; THAT A VACANCY IN THE OFFICE OF CONSTABLE IS HEREBY DECLARED; AND THAT THE GOVERNOR OF THE STATE OF ARKANSAS SHALL BE NOTIFIED FORTHWITH.
