The Grant County Quorum Court met on Tuesday January 22, 2019 at the Grant County Courthouse at 7:00 p.m. with Judge Randy Pruitt presiding. Judge Randy Pruitt called the meeting to order. Members answering **roll call** were Mark Allen, Danny Bone, Brody Channell, Tony Carder, Jim Easley, Mike Nevens, Pat O'Bryan, Jason Roshto, and Grant Westmoreland.

The **Minutes** from the Quorum Court meeting held, **December 17, 2018** were presented to the Quorum Court for review. A motion to accept the minutes was made by Justice Pat O'Bryan and seconded by Justice Mike Nevens. Vote 9 for 0 against.

The **Minutes** from the Quorum Court meeting held, **January 3, 2019** were presented to the Quorum Court for review. A motion to accept the minutes was made by Justice Tony Carder and seconded by Justice Jason Roshto. Vote 9 for 0 against.

The **Financial Statement** was presented to the Quorum Court. Treasurer Tim Stuckey explained how the Grant County Financial Review is read. He also mentioned the jail had to transfer \$12,747.00 in 2018 to cover funds. With no opposition to the Financial Statement as presented, a motion to accept was made by Justice Tony Carder and seconded by Justice Mike Nevens. Vote 9 for 0 against.

Ordinance No. 2019-01, entitled, **AN ORDINANCE ADOPTING THE SUPPLEMENTAL APPROPRIATIONS, TRANSFERS AND REVENUES TO THE GRANT COUNTY BUDGET 2018**. Treasurer Tim Stuckey said no new money was needed for County General except for the new voting machines everything else was paid for. County and Circuit Clerk Gerald D. Harrison, Jr. read **Ordinance No. 2019-01** in its entirety. With no further discussions a motion to accept was made by Justice Mike Nevens and seconded by Justice Jason Roshto. Vote 9 for 0 against.

Ordinance No. 2019-02, entitled, **AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE 2018-06, THE 2019 ANNUAL BUDGET, GRANT COUNTY ARKANSAS IN ORDER TO MAKE ADDITIONAL APPROPRIATIONS AND CORRECTIONS**. Treasurer Tim Stuckey explained fixing the appropriations in the 2019 budget is just a clean up to get us on track for 2019. County and Circuit Clerk Gerald D. Harrison, Jr. read **Ordinance No. 2019-02** in its entirety. Justice Tony Carder asked if money was just being moved around and balanced out. With no further discussions a motion to accept was made by Justice Mike Nevens and Seconded by Justice Mark Allen. Vote 9 for 0 against.

Quorum Court Association Representative. Justice Jason Roshto went over some details on what this position is. This position is our county representative at the AAC. They will have one to two meetings a year and some of the items they discuss are legislative changes.



Comp Time End of the Year 2018 Report. Presented to the Quorum Court reviewed with no further discussion.


Sales Tax was presented to the Quorum Court reviewed with no further discussion.
