The Grant County Quorum Court met on Monday, October 21, 2019 in the Grant County Justice Complex at 7:00 p.m. with Judge Randy Pruitt presiding. Judge Randy Pruitt called the meeting to order. Members answering **roll call** were Mark Allen, Danny Bone, Brody Channell, Tony Carder, Jim Easley, Mike Nevens, Grant Westmoreland, and Jason Roshto.

The **Minutes** from the Quorum Court meeting held, **September 16, 2019** were presented to the Quorum Court for review. With no further discussion, a motion to accept was made by Justice Mike Nevens and seconded by Justice Grant Westmoreland. Vote 8 for 0 against.

The **Financial Statement** was presented to the Quorum Court. With no further discussion, a motion to accept was made by Justice Tony Carder and seconded by Justice Jason Roshto. Vote 8 for 0 against.

National Weather Service; Mr. Dennis Cavanaugh made a presentation to O.E.M. Coordinator Randall Berry recognizing Grant County as a "Storm Ready County". Mr. Cavanaugh explained that Grant County is being recognized for its efforts to raise awareness for our citizens to hazardous weather issues.

Amy Duckworth: Ms. Duckworth is the owner of Tin Top Skating Rink. She asked the Court to please consider not passing an Ordinance pertaining to noise for she felt it would be detrimental to her business as well as other businesses in Grant County. Ms. Duckworth explained all of the improvements that they have done since acquiring the skating rink, and doesn't feel that they can do enough to satisfy the persons wanting a noise ordinance. She explained that the rink has been in operation since 1988, and the neighbor's house has been there since 1992. Ms. Kimberly Phillips who is the previous owner of Tin Top stated that they never felt that they could do enough to please the complaining neighbor. Justice Grant Westmoreland stated that he had researched two (2) or three (3) ordinances to use as a guide if we decide to do anything. He also stated that the noise was loud, but didn't know if it was too loud. He feels that Mr. Earls has a legitimate concern. He did not know if an ordinance was the way to go, and asked the parties to "hit the reset button" and try anew to attempt to work something out between themselves.

Sales Tax: Sales Tax report was presented to the Quorum Court with no discussion.

Other Business: Judge Randy Pruitt informed that RMS had agreed to sell the county ten (10) acres of land adjoining Cox Creek Lake
