

The Grant County Quorum Court met on Tuesday, January 21, 2020 in the Grant County Courthouse at 7:00 p.m. with Judge Randy Pruitt presiding. Judge Randy Pruitt called the meeting to order. Members answering **roll call** were Mark Allen, Danny Bone, Brody Channell, Tony Carder, Jim Easley, Mike Nevens, and Jason Roshto.

The **Minutes** from the Quorum Court meeting held, **December 16, 2019** were presented to the Quorum Court for review. With no further discussion, a motion to accept was made by Justice Mike Nevens and seconded by Justice Jason Roshto. Vote 7 for 0 against.

The **Minutes** from the Special Quorum Court meeting held **December 30, 2019** were presented to the Quorum Court for review. With no further discussion, a motion to accept was made by Justice Tony Carder and seconded by Justice Brody Channell. Vote 7 for 0 against.

The **Financial Statement** was presented to the Quorum Court. With no further discussion, a motion to accept was made by Justice Tony Carder and seconded by Justice Mike Nevens. Vote 7 for 0 against.

Robert Shepherd - SAR Judge Randy Pruitt introduced Robert Shepherd to give report on Grant County SAR. Robert thanked the Quorum Court for their continued support of the SAR Team. He informed the Court that the SAR Team had participated in fourteen (14) rescues in 2019, utilizing the specialized equipment and training that our local SAR Team has. He provided details on some of the rescues that the Team has participated in and upcoming training that the SAR Team has scheduled. Robert explained that because of our Team's specialized training, that we have been called to assist others in search and rescue efforts and this will pay off if or when we ever needed assistance from other Teams.

ORDINANCE NO. 2020 – 01: AN ORDINANCE ADOPTING THE SUPPLEMENTAL APPROPRIATIONS, TRANSFERS AND REVENUES TO THE 2019 ANNUAL GRANT COUNTY BUDGET. Treasurer Tim Stuckey explained that this is the annual cleanup to move necessary items to correct categories. With no further discussion, a motion to approve was made by Justice Mike Nevens and seconded by Justice Jason Roshto. Vote 7 for 0 against.

ORDINANCE NO. 2020 – 02: AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE 2019 – 08, THE 2020 ANNUAL BUDGET, GRANT COUNTY ARKANSAS IN ORDER TO MAKE ADDITIONAL APPROPRIATIONS AND CORRECTIONS. Treasurer Tim Stuckey explained that this is to correct items either named or categorized incorrectly. With no further discussion a motion to accept was made by Justice Mike Nevens and seconded by Justice Jason Roshto. Vote 7 for 0 against.

Quorum Court Delegate 2020: Judge Randy Pruitt stated that the current Delegate for Grant County is Justice Jim Easley. He stated that we need someone to volunteer to be the 2020 Delegate and attend the Delegate Meeting once per year. Justice Brody Channell will be the new Delegate for 2020.

Sales Tax: Sales Tax report was presented to the Quorum Court with no discussion.

Other Business: Judge Randy Pruitt informed the Court that the Solar Contract is still in the same place as the last meeting. He stated that Josh said that some of it had been changed but they are still working on it. Judge Pruitt stated that as soon as he gets the updated contract he will forward to the attorneys. He stated that Entergy was going to give the County an estimate but the cities estimate from them was about \$7000.00 less savings than with Clear Energy. He stated as soon as the attorneys have looked over everything there would be another meeting on Solar called.
