The **Financial Statement** was presented to the Quorum Court. Treasurer Tim Stuckey explained current Property Tax dropped but will pick back up in June. Circuit Court fees are good, District may not catch back up. He explained that the Internet Sales Tax from March — May was up 20%. Road Department page 5 of review shows that Turnback is positive and will be again in June. Prediction is the hit may be only 9% vs. 50% predicted. Sales Tax: Sales Tax report was presented to the Quorum Court with no discussion.

**Other Business:** Judge Randy Pruitt informed that the Road Department has 20 miles of road to resurface. Due to Covid 19, he has cancelled the purchase of an asphalt lay down machine for now.
