The Grant County Quorum Court met on Monday, November 16, 2020 in the Grant County Courthouse at 7:00 p.m. with Judge Randy Pruitt presiding. Judge Randy Pruitt called the meeting to order. Members answering **roll call** were Mark Allen, Danny Bone, Tony Carder, Brody Channell, Jim Easley, Mike Nevens, Bobby Pierce, Jason Roshto, and Grant Westmoreland.

The **Minutes** from the Quorum Court Meeting held, **October 19, 2020** were presented to the Quorum Court for review. With no further discussion, a motion to accept with corrections was made by Justice Tony Carder and seconded by Justice Bobby Pierce. Vote 9 for 0 against.

The **Financial Statement** was presented to the Quorum Court. With no further discussion, a motion to accept was made by Justice Tony Carder and seconded by Justice Mike Nevens. Vote 9 for 0 against.

Ordinance No. 2020 – 09: "AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE 2019-08, THE 2020 ANNUAL BUDGET, GRANT COUNTY, ARKANSAS. Treasurer Tim Stuckey explained this is the appropriation for the Cares Act Grant. Justice Tony Carder questioned if we had an end of year deadline? Judge Randy Pruitt explained that everything had been approved except Air Unit for Courthouse. Treasurer Tim Stuckey said hopefully everything will be in by year end. With no further discussion a motion was made by Justice Mike Nevens and seconded by Justice Jason Roshto to approve. Vote 9 for 0 against.

Ordinance No. 2020 - 10: "AN ORDINANCE LEVYING THE MILLAGE RATES FOR ALL COUNTY TAXES FOR THE YEAR 2020 TO BE PAID IN THE YEAR 2021. With no further discussion a motion to suspend the second (2nd) reading was made by Justice Tony Carder and seconded by Justice Mike Nevens. Vote 9 for 0 against. After second (2nd) reading "Title Only", a motion to suspend the third (3rd) reading was made by Justice Tony Carder and seconded by Justice Mike Nevens. Vote 9 for 0 against. After third (3rd) reading "Title Only", a motion to adopt was made by Justice Tony Carder and seconded by Justice Mike Nevens. Judge Randy Pruitt asked if there was any additional discussion. With no further discussion vote 9 for 0 against.

Sales Tax: Sales Tax Report was presented to the Quorum Court with no discussion.

Other Business: Justice Grant Westmoreland asked about excavation on North end of town. Justice Bobby Pierce stated that he thought the drive through was completely down.
