Members answering roll call were Mark Allen, Danny Bone, Tony Carder, Jim Easley, Mike Nevens, Pat O'Bryan, Jason Roshto, and Grant Westmoreland.

**MINUTES:** The Minutes from the November 15, 2021, Quorum Court Meeting were presented. With no further discussion a motion to accept was made by Justice Mike Nevens and seconded by Justice Grant Westmoreland. Vote 8 for 0 against.

**FINANCIAL STATEMENT:** The Financial Statement was presented to the Quorum Court. With no further discussion a motion to accept was made by Justice Tony Carder and seconded by Justice Mike Nevens. Vote 8 for 0 against.

**ORDINANCE 2021 – 14: AN ORDINANCE TO ESTABLISH THE ANNUAL OPERATING BUDGET FOR CALENDAR YEAR 2022; APPROPRIATING FUNDS FOR THE OPERATING ACCOUNTS; APPROPRIATING TRANSFERS; AND FOR OTHER COUNTY BUDGET PURPOSES:** After first (1<sup>st</sup>) reading of Ordinance 2021 – 14 and no further discussion, a motion to suspend second (2<sup>nd</sup>) reading was made by Justice Pat O'Bryan and seconded by Justice Mike Nevens. Vote 8 for 0 against. After second (2<sup>nd</sup>) reading "Title Only", a motion to suspend third (3<sup>rd</sup>) reading was made by Justice Mike Nevens and seconded by Justice Pat O'Bryan. Vote 8 for 0 against. After third (3<sup>rd</sup>) reading "Title Only" a motion to adopt was made by Justice Mike Nevens and seconded by Justice Grant Westmoreland. With no further discussion, Vote 8 for 0 against.

**ORDINANCE 2021 – 15: AN ORDINANCE TO ESTABLISH A GENERAL REVENUE FUND TO BE CALLED ARP UNRESTRICTED FUND; AND TO DECLARE AN EMERGENCY:** After first (1<sup>st</sup>) reading of Ordinance 2021 – 15 and no further discussion, a motion to suspend second (2<sup>nd</sup>) reading was made by Justice Mike Nevens and seconded by Justice Mark Allen. Vote 8 for 0 against. After second (2<sup>nd</sup>) reading "Title Only" a motion to suspend third (3<sup>rd</sup>) reading was made by Justice Mike Nevens and seconded by Justice Jim Easley. Vote 8 for 0 against. After third (3<sup>rd</sup>) reading "Title Only" a motion to adopt was made by Justice Mike Nevens and seconded by Justice Jason Roshto. Vote 8 for 0 against.

**ORDINANCE 2021 – 16: AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE 2020 – 11, THE ANNUAL BUDGET, GRANT COUNTY ARKANSAS:** After reading of Ordinance 2021 – 16 and no further discussion, a motion to approve was made by Justice Mike Nevens and seconded by Justice Tony Carder. Vote 8 for 0 against.

**SALES TAX:** The Sales Tax report was presented to the Quorum Court.

**OTHER BUSINESS:** Judge Randy Pruitt explained that we had disposed of some Surplus Equipment from the Road Department.
