MICHAEL MICHAEL - GRANT COUNTY FAIR BOARD: Judge Randy Pruitt introduced Michael Michael President of Grant County Fair Board. Mr. Michael spoke to the Court about the "new" Fairgrounds located on 167 North and the struggles that the Fair Board has had in moving to the new location. He informed that by next year the Grant County Fair and Rodeo should all be located at the new location. He thanked the Court for their continued support of the Fair Association and hoped that our relationship could continue. He asked if the County would assist in purchasing a cover for the new arena being built. Justice Mike Nevens asked if he had a cost estimate for the arena cover. Mr. Michael informed that the cost to cover the arena is \$1.3 million unless the price has increased since they received pricing and requested that they have a cost share with the County. After discussion, Mr. Michael agreed to put together a financial plan and review and submit to the Court for consideration

DISTRICT COURT AUTOMATION FUND: Jude Randy Pruitt explained this is for a computer that was purchased and approved by Judge Gibson. With no discussion a motion to approve was made by Justice Grant Westmoreland and seconded by Justice Jason Roshto. Vote 7 for 0 against.
