The Grant County Quorum Court met on Monday, December 19, 2022, in the Grant County Courthouse at 7:00 p.m. with Judge Randy Pruitt presiding. Judge Randy Pruitt called the meeting to order. ORDINANCE NO. 2022-14: AN ORDINANCE TO ESTABLISH THE ANNUAL OPERATING BUDGET FOR CALENDAR YEAR 2023; APPROPRIATING FUNDS FOR THE OPERATING ACCOUNTS; APPROPRIATING TRANSFERS; AND FOR OTHER COUNTY BUDGET PURPOSES: Treasurer Tim Stuckey explained some changes to the original copy that were corrections. Justice Mike Nevens discussed the work done by the Budget Committee and referenced that this was a "tough budget" for the Committee to get through. He highlighted that the County health insurance is increasing thirty-nine percent (39%). The budget includes a four percent (4%) payroll increase and five hundred thousand dollars (\$500,000.00) for the Annex property. There was discussion about the purchase of "Extracation Equipment" for the Fire Districts and a ninety / ten Grant (90% - 10%) to place computers in the Sheriff Department vehicles. A motion to approve was made by Justice Mike Nevens and seconded by Justice Grant Westmoreland. Judge Randy Pruitt asked if there is any more discussion. With no further discussion, vote 7 for 0 against

**SALES TAX:** The Sales Tax report was presented to the Quorum Court.

**OTHER BUSINESS:** Judge Randy Pruitt presented outgoing Justice Pat O'Bryan with a clock commemorating his years of service to the Grant County Quorum Court.
