The Grant County Quorum Court met on Tuesday, January 16, 2024, in the Grant County Courthouse at 7:00 p.m. Grant County Judge Randy Pruitt called the meeting to order. Members answering roll call were Mark Allen, Danny Bone, Tony Carder, Paul Drake, Jim Easley, Mike Nevens, Jason Roshto, and Scott Wells.

**MINUTES:** The Minutes from the December 18, 2023, Quorum Court Meeting were presented. With no further discussion a motion to accept was made by Justice Mike Nevens and seconded by Justice Paul Drake. **Vote 8 for 0 against.** (Motion passed)

**Financial Statement:** The Financial Statement was presented to the Quorum Court. With no further discussion a motion to accept was made by Justice Mike Nevens and seconded by Justice Jason Roshto. **Vote 8 for 0 against.** (Motion Passed)

**APPROPRIATION ORDINANCE 2024-01: AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE 2023-14, THE 2024 ANNUAL BUDGET, GRANT COUNTY ARKANSAS:** Treasurer Tim Stuckey commented that this Ordinance represents donations that the Grant County Sheriff's Office received to purchase a tracking dog. Judge Randy Pruitt talked about the value of such a dog during Search and Rescue Operations. Ordinance 2024-01 was read to the Quorum Court. A motion to pass was made by Justice Mike Nevens and seconded by Justice Jason Roshto. Judge Randy Pruitt asked if there was any discussion. With no further discussion **Vote 8 for 0 against.** (Passed)

**District Court Automation Fund:** Judge Randy Pruitt explained this was to approve expenses paid by the City of Sheridan for security cameras and zoom cameras in the District Courtroom. After no discussion, a motion to approve was made by Justice Jason Roshto and seconded by Justice Jimmy Easley. **Vote 8 for 0 against** (Passed)

**SALES TAX:** The Sales Tax report was presented to the Quorum Court.

**OTHER BUSINESS:** Judge Randy Pruitt asked if there was a need to move the date of the scheduled March 18, 2024, Quorum Court meeting due to it falling during Spring Break. A motion to move the meeting date to March 11, 2024, was made by Justice Mike Nevens and seconded by Justice Paul Drake. With no further discussion **Vote 8 or 0 against.** (Motion passed)
