ORDINANCE NO. 2017-12

ENACTED BY THE QUORUM COURT OF THE COUNTY OF
STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED:
"AN ORDINANCE TO ESTABLISH THE ANNUAL OPERATING BUDGET
FOR CALENDAR YEAR 2018."

SECTION 1. The annual budget for calendar year 2018 identified as "Grant County Budget 2018" is hereby adopted by reference. A copy of said budget shall be filed in the Office of the County Clerk and shall be available for inspection and copying by any person during normal office hours.

SECTION 2. This Ordinance establishes a 2018 budget for the following operating funds: County General, County General Reserve, Emergency Services Reserve, DTF Vehicle, County Road, Treasurer Automation, Collector Automation, Circuit Court Automation, Assessor Amendment 79, County Clerk Cost, County Recorder, County Library, Solid Waste, Drug Control, Alcohol Testing/Breathalyzer, Jail Operation Maintenance, 911, Emergency Medical 2009 Tax, Victim Witness, Public Defender/Indigent Defense, Public Safety, Juvenile Probation Fee, Criminal Justice, Airport, Late Assessment Fee, Grant County Rescue, County Law Library, Special Forfeiture, Fingerprint Service, Emergency Medical 2017 Tax, Solid Waste Recycle, Project Lifesaver.

SECTION 3. Special fund maintained by the Grant County Museum so titled "Museum Special Fund" and special fund maintained by the Grant County Sheriff so titled "Sheriff Radio Fund" are hereby included in the Grant County Budget 2018.

SECTION 4. Expenditure of funds appropriated by this Ordinance shall not be restricted to the line item expenditure codes comprising the major categories of expenditures - Personal Services, Supplies, Other Services and Charges, Capital Outlay, and Debt Service - but shall be restricted to office/departments expenditures within the above enumerated major categories of expenditures except for funds appropriated for personnel salaries and wages and related employee benefits. Personnel expenditures shall not exceed the dollar amounts, number of employees, and salary or wage rates specified in the annual budget or an amendment thereto.

SECTION 5. No expenditure of appropriated funds shall be made from any fund other than the fund specified in this Ordinance, or an amendment thereto.

SECTION 6. Any transfers of monies between the various funds of the County or between the major categories of expenditures - Personal Services, Supplies, Other Services and Charges, Capital Outlay, and Debt Service - shall be made only with the approval of the Grant County Quorum Court. Provided, however, all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.

SECTION 7. If any provision of the Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provision or applications of the Ordinance which can be given effect without the invalid provisions or applications, and to this end, the provisions of this Ordinance are declared to be severable.

SECTION 8. This Ordinance being necessary for the protection and preservation of public health and safety, an emergency is hereby declared to exist and this Ordinance shall be in force and shall take effect upon passage and approval.
