"AN ORDINANCE ADOPTING THE SUPPLEMENTAL APPROPRIATIONS AND TRANSFERS TO THE ANNUAL OPERATING BUDGET FOR CALENDAR YEAR 2016."

SECTION 1. The supplemental budgets for calendar year 2016 identified as "Grant County Supplemental Budgets Year 2016" is hereby adopted by reference. A copy of said supplemental budgets shall be filed in the Office of the County Clerk and shall be available for inspection and copying by any person during normal office hours.

SECTION 2. This Ordinance establishes supplemental appropriations and transfers to the 2016 budget for the following funds: County General, County Road, Circuit Court Automation, County Library, Solid Waste, Jail Operation & Maintenance, 911, Victim Witness, Criminal Justice, Airport, Grant County Rescue, County Law Library and Law Enforcement Grant.

SECTION 3. Said Supplement Budgets are hereby adopted by the Quorum Court and the County Judge is hereby authorized to approve expenditures consistent therewith as and when the same shall be needed and the Quorum Court further specifically appropriates and authorizes any previous expenditures consistent therewith made and approved by the County Judge for the calendar year 2016.

SECTION 4. This Ordinance shall constitute appropriations for the purposes specified in said Budgets for the calendar year 2016 subject only to revision or modification by the Quorum Court.

SECTION 5. This Ordinance shall also reflect unanticipated revenues for the 2016 County Budgets.

SECTION 6. If any provision of the Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provision or applications of the Ordinance which can be given effect without the invalid provisions or applications, and to this end, the provisions of this Ordinance are declared to be severable.

SECTION 7. This Ordinance being necessary for the protection and preservation of public health and safety, an emergency is hereby declared to exist and this Ordinance shall be in force and shall take effect upon passage and approval.
